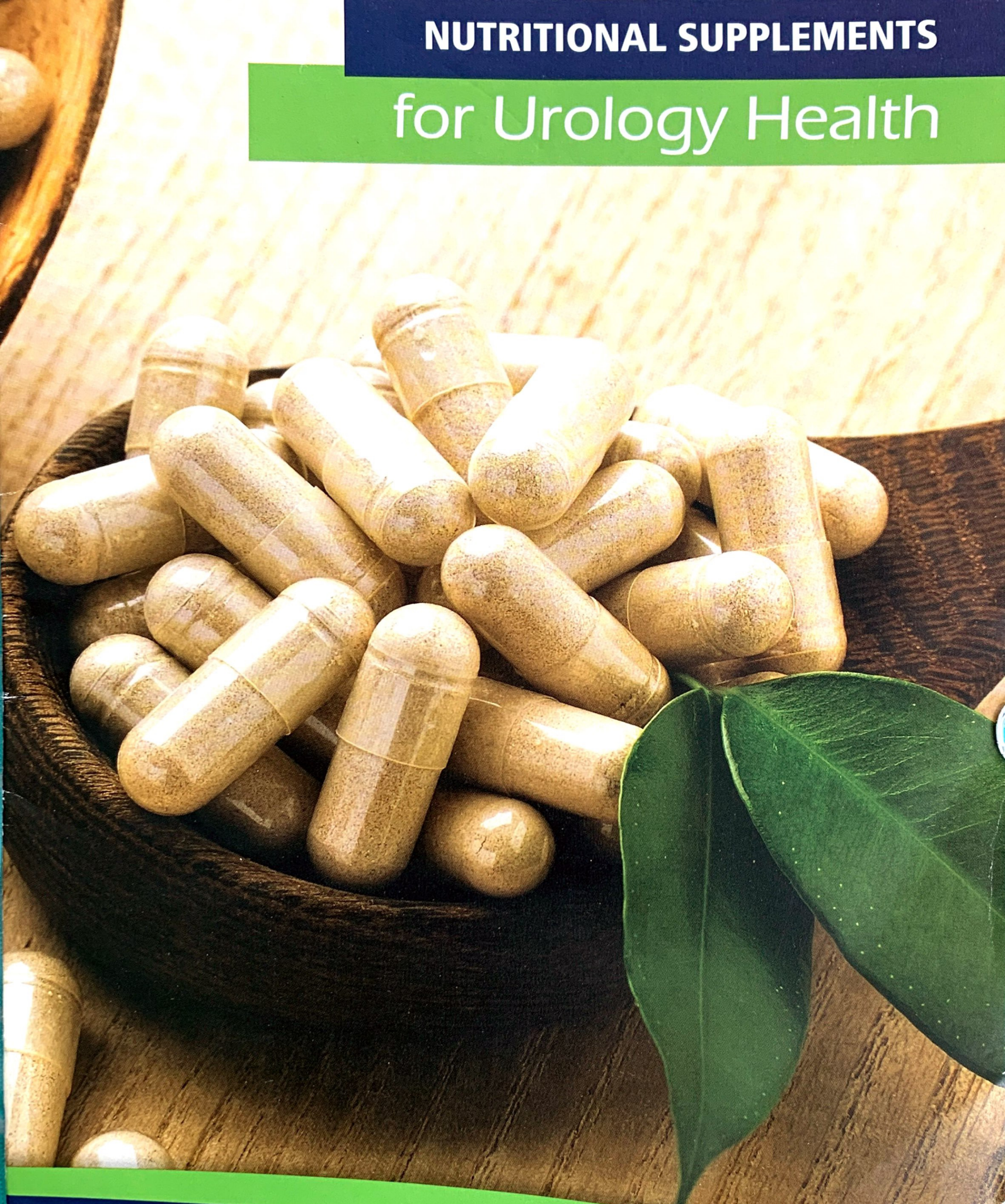




**Contents Tested & Certified**

## About Cranberries and Urinary Tract Health

Cranberries are commonly recommended for urinary tract health. Research has revealed that cranberries naturally contain a group of compounds called proanthocyanidins (PACs), which are thought to be responsible for their benefits.

Studies have shown that most people need at least 36 mg of PACs a day to see results. Eight to ten ounces of 27% cranberry juice cocktail provides this dose of PACs. However, for those trying to manage their weight or blood sugar levels, the extra calories and sugar in cranberry juice can add up over time.

Dried cranberry extract is also more stable than juice, which loses its bioactivity the longer it sits on a shelf. A cranberry supplement can provide a stable, low-calorie alternative to sugar-laden cranberry cocktail.

Each capsule contains 36 mg of PACs<sup>†</sup>, the amount that has been shown in scientific studies to promote urinary tract health.\*

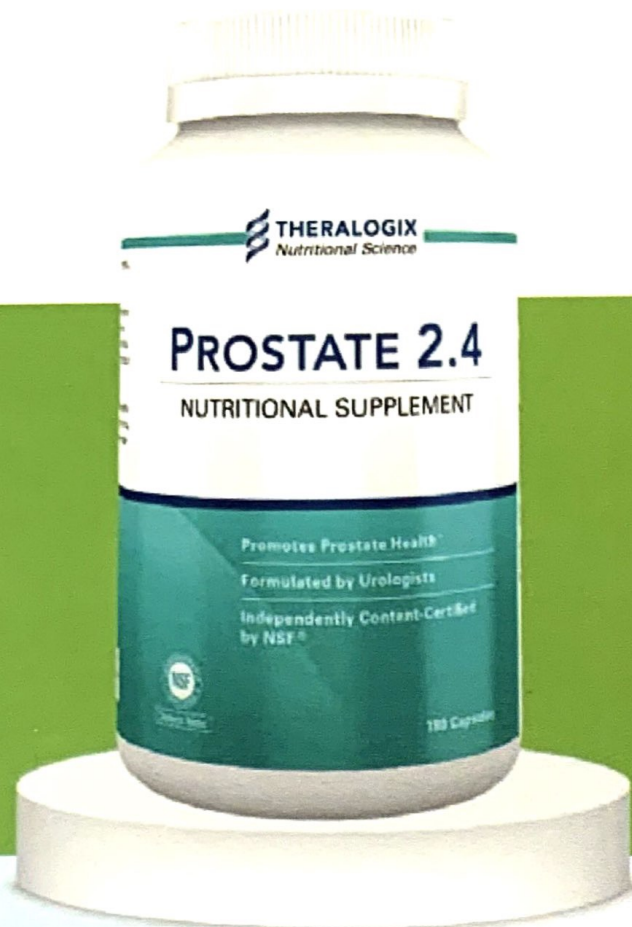
